ORDINANCE NO. 002-2014

CALLING A SPECIAL BOND ELECTION IN THE NIXA FIRE PROTECTION DISTRICT (THE "DISTRICT"), TO BE HELD ON TUESDAY, NOVEMBER 4, 2014, REGARDING ISSUING GENERAL OBLIGATION BONDS, IN AN AMOUNT NOT TO EXCEED TWO MILLION FIVE HUNDRED SEVENTY FIVE THOUSAND DOLLARS (\$2,575,000), FOR THE PURPOSE OF PAYING ALL OR A PORTION OF THE COSTS OF CONSTRUCTING, IMPROVING, ACQUIRING, AND INSTALLING ADDITIONAL FIRE FIGHTING FACILITIES AND EQUIPMENT FOR THE DISTRICT; DESIGNATING THE TIME FOR HOLDING SUCH ELECTION; AUTHORIZING THE CLERK TO GIVE NOTICE OF SAID ELECTION; AND AUTHORIZING ELECTION OFFICIALS TO DO ALL THINGS NECESSARY TO CARRY OUT THE ELECTION.

BE IT ORDERED BY THE BOARD OF DIRECTORS OF THE NIXA FIRE PROTECTION DISTRICT, AS FOLLOWS:

Section 1. That a special bond election be and the same is hereby called and ordered to be held in the Nixa Fire Protection District, on Tuesday, the 4th day of November, 2014, for the purpose of testing the sense of the qualified voters of said District upon the following proposition:

Shall the Nixa Fire Protection District issue and sell general obligation bonds in an amount not to exceed Two Million Five Hundred Seventy Five Thousand Dollars (\$2,575,000) for the purpose of paying all or a portion of the costs of constructing, improving, acquiring, and installing additional firefighting facilities and equipment for the district.

The authorization of said bonds will authorize the levy and collection of an annual tax in addition to the other taxes provided for by law on all taxable tangible property in said District sufficient to pay the interest and principal of said bonds as they fall due and to retire the same within ten years from the date thereof.

Section 2. The Board has determined that the interests of the District and the public interest and necessity demand the acquisition, construction, installation and completion of a new fire station building, and the equipping of that building. The estimated costs of the works, improvements and equipment for this project are estimated at \$2,575,000, and the District intends to reimburse itself from the proceeds of the general obligation bonds for any funds advanced by the District for costs of the project.

Section 3. The maximum rate of interest to be paid on the general obligation bonds will not exceed 6% per annum.

Section 4. The District Clerk is hereby authorized and directed to notify the County Clerks of Christian County and Stone County, Missouri, of the adoption of this order no later than 5.00 o'clock P.M. on the tenth Tuesday prior to the date of the election, and to include in said notification all of the terms and provisions required by Chapter 115 RSMo., as amended.

Section 5. That said election shall be held in the several wards and precincts of said District, in voting places as shall be established therein by the District Clerk or the County Clerks as required by Chapter 115 RSMo., as amended, and the polls shall be open on said election day during the hours provided by law.


Section 6. The District Clerk and the County Clerks of Christian County and Stone County, Missouri, are hereby authorized and directed to conduct such election in a manner consistent with the provisions of Chapter 115 RSMo., as amended.

Section 7. The form of the notice of special election for said special election, a copy of which is attached hereto and incorporated herein by reference, is hereby approved.

Section 8. All order or parts of order in conflict herewith be and the same are hereby repealed insofar as they are in conflict. Any provision of this order in conflict with Chapter 115 RSMo., as amended, shall be null and void and shall be superseded. Appropriate public officials are hereby authorized to take any and all action to comply with Chapter 115 RSMo., as amended.

Section 9. This order shall be in full force and effect from and after passage and approval. Read, agreed to and passed this the _____ day of _____, 2014.
